6.1 Physician Recruiter Hiring Update

Leanne Gowing provided an update on the hiring process and next steps for the Physician Recruiter/Clinic Manager. Interviews have been scheduled and will be held via Zoom. It is anticipated that the successful candidate will be introduced at the next meeting.

6.2 Incentive Package Review/Proposal

Angela Cavanagh provided an overview of the proposal presented by the Physician's Group. Gary Gurbin overviewed the retention proposal.

The group discussed specialists and that the municipality would not offer the incentive package to them as they are hired through the hospital. They mentioned that they would be supportive of specialists coming into the community and look to support them in other ways.

Councillor Couture added that she would be supportive of the Golf membership offered in the existing package being extended to 5 seasons, the Davidson Centre programming be expanded to include recreation programs, and that \$40,000 be provided to new physicians upfront and that the Municipality implement a \$60,000 interest free loan for the the purchase of a home.

Gary Gurbin outlined that garbage, EMR, and cleaning are key issues. He added that these items should be budgeted for on an annual basis.
