6.1 Trails Committee

7.1 Infrastructure and Development

a. Wood Access Saugeen Street - Surplus Land, -2022-03

THAT Council declare the land identified as PART 1 on the draft reference plan attached as Schedule A, which is part of Part 11, Plan 1233 Deposited as R93684A, Kincardine; being part of PIN 33311-0195(LT) ("PART 1"), as surplus to the needs of the Municipality of Kincardine;

THAT Council support the conveyance of PART 1 to the Owner of 928 Saugeen Street, Kincardine for \$6,000.00 plus HST in accordance with Minutes of Settlement signed August 9, 2021;

THAT the disposal of PART 1 be deemed exempt from the requirement to provide public notice in the form of a post in a newspaper having general circulation as per Section 4 of By-law No. 2008-141 and that public notice by posting on the Municipality's webpage is sufficient in the circumstance;

THAT the disposal of PART 1 be deemed exempt from Section 6 Marketing of Properties of By-law No. 2008-141, which includes the requirement to market land by local real estate, listing through MLS and the posting of a real estate sign;

THAT Committee of the Whole recommend that the Mayor and CAO be hereby authorized to sign on behalf of the Corporation of the Municipality of Kincardine any documents required to allow disposal procedures to commence;

THAT Committee of the Whole recommend Council instruct staff to complete the transaction;
