Funding is available to assist Indigenous Nations and communities, members of the public and stakeholders in reviewing CNSC staff's Regulatory Oversight Report on the Use of Nuclear Substances in Canada: 2021 and in submitting comments in writing to the Commission.

The regulatory oversight report (ROR) provides an overview of our assessment of the safety performance of licensees in the medical, industrial, academic and research, and commercial sectors that used nuclear substances in Canada in 2021. The ROR will be available for review on our website, or on request to the Registry after August 19.

A public meeting will be held November 2 and 3, during which our staff will present the report to the Commission. Members of the public who have an interest or expertise in this matter are invited to comment in writing, by October 3.
