I am pleased to provide with this letter a copy of *Implementing Adaptive Phased Management 2022 to 2026*, the five-year strategic plan for the Nuclear Waste Management Organization (NWMO). The enclosed document outlines our plans for 2022 to 2026 and explains how Canada's plan will be implemented during that time period. The NWMO is responsible for implementing Canada's plan for the safe, long-term management of used nuclear fuel in a manner that protects people and the environment for generations to come.

The plan, called Adaptive Phased Management (APM), is currently in the site selection phase. In 2021, the need to continue to adjust to the pandemic demonstrated why that adaptive approach is so essential to the long-term success of Canada's plan. The next five years will see the NWMO continue to adapt as we reach the site selection milestone and move into the regulatory decision-making process.

In that time, we will work with potential host communities to define partnership and determine willingness, and in 2023, we will select a preferred site for the deep geological repository. Following site selection, we will take on a new series of activities: implementing partnership agreements with host communities; finalizing the safety case for the identified site; beginning to construct a Centre of Expertise; preparing for and participating in the regulatory decision-making process; and beginning to move our operations to the site that is selected.

Throughout the 2022-26 planning period, we will conduct environmental baseline monitoring to inform our work so we can avoid, prevent and mitigate any environmental impact. We will complete more deep borehole drilling and other technical evaluations to inform the technical design and safety case for our work. We will also continue to engage with Canadians and Indigenous peoples as we plan for the eventual transportation of used nuclear fuel to a central repository location.
