4. <u>New Business</u>

4.1 Sidewalk Patio Application – Locals Pub & Eatery, Kincardine

The Committee had the following comments or concerns regarding the application:

- Concerns raised regarding safety of the patios on a busy corner;
- Would like the site monitored, to ensure no further obstructions are created by the Big Dig Queen Street construction;
- Request regular municipal inspections of the patios, to ensure the minimum path of travel routes are maintained;
- Ensure the patios do not interfere with the pedestrian traffic light activation;
- Concerned that the current sidewalk on Durham Street does not meet the minimum recommendation of 63 inches (preferred 72 inches) as noted in the FADS;
- Concerned about having the tables against the building on Queen Street, does not give a direct path of travel;
- Adequate space is provided between tables to allow access to the chairs, without having to move them into the path of travel;
- If the Durham Street patio meets the minimum path of travel width, the patio tables and chairs be of appropriate size to be located completely within the grassed area, to maintain the minimum 63 inches path of travel; Also, the fence rope bollards be in a location to maintain the minimum 63 inches path of travel;
- Suggest a parking area for mobility devices and strollers to be stored by patrons;
- Recommend an accessible table be provided to accommodate mobility devices and strollers;
- Suggest 3 inches be added to the edge of the sidewalk, to accommodate the minimum 63 inch path of travel, if applicable.

That the Accessibility Advisory Committee recommend that the Durham Street side of the Locals Pub & Eatery sidewalk patio be denied, if the sidewalk path of travel does not meet the minimum 63 inches to comply with the Facility Accessibility Design (FAD) Standards.
