## **BY-LAW**

## Being a By-law to Amend By-law No. 2022 - 162; Being a By-law to Establish Rates and Fees for Services Performed by The Municipality of Kincardine

**Whereas** Section 391 (1) of the Municipal Act 2001, S.O. 2001, c. 25, as amended, authorizes municipalities to pass by-laws imposing fees or charges on persons,

- (a) for services or activities provided or done by or on behalf of it;
- (b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board;
- (c) for the use of its property including property under its control. and

**Whereas** municipal Councils have the authority to establish rates and fees under various acts; and

Whereas the Council of The Corporation of the Municipality of Kincardine, with the passage of By-law No. 2022 – 162, as amended, established rates and fees for services performed by the Municipality; and

Whereas the Council of The Corporation of the Municipality of Kincardine deems it necessary to amend Schedule 'G' of By-law No. 2022 - 162 to add Advertising and Partnership Program fees; now therefore be it

**Resolved** that the Council of The Corporation of the Municipality of Kincardine **Enacts** as follows:

- 1. That Schedule 'G' of the Municipality of Kincardine 2023 Consolidated Rates and Fees By-law No. 2022 162, is hereby amended with the additional fees as outlined on the attached Schedule 'A'.
- 2. That this By-law shall come into full force and effect upon its final passage.
- 3. That this By-law may be cited as the "2023 Consolidated Rates and Fees Amendment (6) By-law".
