Whereas Council passed By-law 2022 - 164 on November 14, 2022 which amended By-law No. 2003 -25 to include a Holding (h) Provision on certain lands; and

Whereas all the conditions of the Holding (h) Provision have been satisfied; and

Whereas the Council of The Corporation of the Municipality of Kincardine desires to amend By-law 2003 - 25; now therefore be it

Resolved that the Council of The Corporation of the Municipality of Kincardine **Enacts** as follows:

- 1. Schedule 'A' to By-law No. 2003 25 as amended, is hereby further amended by changing the zoning from "EC12-a-h" to "EC12-a" the zoning designation of those lands outlined on the attached Schedule 'A'
- 2. This By-law takes effect from the date of passage by Council and comes into force and effect pursuant to the provisions of the Planning Act, R.S.O. 1990.
- 3. This By-law may be cited as the "Amendment to Zoning By-law No. 2003-25, Holding Removal (Business and Innovation Centre Inc.) By-law".
