Board in completing three projects that focus on evidence-based policies that address the challenges faced by Rural Ontario. These projects are aimed at helping Rural Ontario rebound from COVID-19, improving housing and increasing access to health services, while providing proactive and concrete solutions to these challenges. I am pleased to say that the government has responded positively to these projects and we are making progress.

This work has provided me with a strong foundation to shoulder the leadership that your next AMO President will need in the coming years. These are increasingly challenging times for Ontario's municipalities. During the project research, I had the opportunity to discuss the issues with municipal mayors and leaders across the province. I understand the frustrations that we all share about the opioid crisis, homelessness, and mental illness that are wreaking havoc in our communities. These issues are breaking our communities, spirits and in some cases, the banks. My experience at the MOU table has emphasized the importance of consultation between the Province and Ontario's municipal governments.

While it's true that the MOU table holds a significant position in our organization and is considered to be a valuable and respected institution,

it's also true that some critical matters might not make it to the table. It's important to ensure that all issues are addressed and resolved, regardless of whether or not they are discussed at the MOU table.

If I am elected, I will work towards improving the relationship and creating a stronger partnership between municipalities and the provincial government. My experience as Chair of ROMA has enabled me to establish positive relationships with various Ministers, MPPs, and provincial staff. It is essential to have strong and committed relationships with members of the provincial government to ensure effective governance and tackle local challenges. It is crucial to recognize the role of municipalities in delivering essential services and implementing provincial programs efficiently. In the past, outdated regulations, disjointed policy announcements, and a lack of action on initiatives that are important to you have posed obstacles. We can overcome these challenges by developing more effective partnerships and improving communication.

I am committed to supporting the AMO Social and Economic Prosperity Review and working collaboratively with municipalities and the government to thoroughly analyze revenues, costs, and financial risks. This includes a detailed evaluation of Ontario's infrastructure investment and service delivery requirements.
