On February 20, 2019, Council passed Budget By-Law No. 2019 - 026. At that time, the education tax rates for Ontario had not yet been established. The 2019 residential education tax rate has now been set at 0.00161, down from 0.0017 in 2018. When combined with the Municipal and County rates, the total residential tax rate is 0.01228528, which is an increase of 1.7% over the prior year. For the average residential assessment of \$270,000, this amounts to an increase in property taxes of \$54.
