

This Agreement is entered into as of this 22nd day of June, 2024 (the "Effective Date")

BETWEEN

THE CORPORATION OF THE MUNICIPALITY OF KINCARDINE

Hereinafter referred to as the

"Municipality" and

Kincardine & District Lions Club

Hereinafter referred to as the "Lions Club"

WHEREAS the Municipality and the Lions Club wish to enter into an agreement whereby the Lions Club will place and remove road closed barricades and remove and replace covers on temporary accessible parking spaces for the Queen Street Pipe Band Closures;

NOW THEREFORE IN CONSIDERATION of the undertakings and agreements hereinafter expressed by the Parties, the Municipality and the Lions Club mutually covenant and agree as follows:

1. For the Queen Street Scottish Pipe Band Closures, the Lions Club will place road closed barricades out before the parade starts and place them back to the side once the parade has completed.

1. The Lions Club shall provide this service on Saturdays as

follows: June 22

June 29

July 6

July 13

July 20

July 27

August 3

August 10

August 17

August 31

with the closed road barricades to be placed in position between 7:30 p.m. (8pm event start) and 9:00 p.m (whenever the band has finished)

2. The Municipality will place the road closed barricades in the general area where they are to be used.
3. The Municipality will provide safety vests for use by the Lions Club while performing this work.
4. The Municipality will pay \$320 per weekend (10 weekends for a total \$3,200) to be paid in one installment at the end of the agreement.
5. In the event of problems (barricades or signs missing, etc.) the Lions Club will contact the Municipality by telephone at 519.389.1012.
6. The Lions Club shall put in effect and maintain in its name, at its expense; Commercial General Liability Insurance, for third party bodily injury, personal injury and property damage to an inclusive limit of not less than Two Million Dollars (\$2,000,000.00) per occurrence. The policy shall include:
The Corporation of the Municipality of Kincardine as an additional insured; Cross liability;
Contractual liability;
A thirty (30) day written notice of cancellation.

The Lions Club shall provide the Municipality with a valid Certificate of Insurance as evidence of the above coverages upon signing the agreement.

7. This agreement shall continue to September 1, 2024 unless either party terminates this agreement by giving the other party sixty (60) days advance written notice that they wish to terminate this agreement.

IN WITNESS WHEREOF, the Parties have caused this agreement to be executed by their duly authorized representatives to be effective as of the Effective Date stated at the top of this Agreement.
