Executive Summary:

With the declaration of the vacant seat of Councillor Ward 1 at the September 11, 2024 meeting, the Committee positions held by Councillor Kennedy also become vacant. Councillor Kennedy represented the Municipality on Bruce Area Sold Waste Recycling (BASWR) Board, the Saugeen Mobility and Regional Transit (SMART) and the Community Investment Grant Review Team.Council will consider whether to fill these vacancies temporarily until the Council position is appointed or appoint a member to fill the position for the remainder of the term. Council may also review their current appointments to consider changes to Council appointments on existing committees, if desired.The next meeting of BASWR is October 24, 2024, at 9 a.m. and the next meeting of SMART is September 27, 2024 at 10 a.m.

Context and Background Information:

On September 11, 2024, the office of Councillor Ward 1 was declared vacant. As such, the committee seats held by Councillor Kennedy have also become vacant. Councillor Kennedy sat on:

- BASWR;
- SMART; and
- Community Investment Grant Review Team.

Options

Council has the following options to fill the vacancies.

Option 1 - Temporarily fill the vacancy until the vacant seat of Councillor Ward 1 is appointed. At that time, Council can review the positions again with a full Council complement and decide on filling the vacancy permanently. This could include a mid-term review of the existing Council appointments to various committees to determine if there are any changes desired.

Option 2 – Fill the Vacancy permanently among the existing complement of Council members.

Committee Roles and Time Commitment

Bruce Area Solid Waste Recycling (BASWR)

The next meeting for BASWR is **Thursday October 24, 2024, at 9 a.m.** They meet monthly during the day for approximately one (1) hour.

The Board consists of 7 municipal representatives, one each from Arran-Elderslie, Brockton, Huron-Kinloss, Kincardine, Saugeen Shores, South Bruce and South Bruce Peninsula. The Municipality sends one Council member to be our representative on the Board.

The Municipality is 1/7th owner of BASWR and BASWR provides the garbage and recycling services for the Municipality of Kincardine. One of the major items being dealt with by this Board is the implications of <u>Blue Box Regulation O. Reg 391/21</u>.

Saugeen Mobility and Regional Transit (SMART)

The next meeting of SMART is **Friday September 27, 2024, at 10 a.m.** and then on Friday October 25, 2024 at 10 a.m. They meet on the last Friday of the month during the day for approximately three (3) hours.

The Board consists of 10 municipal representatives, one each from Huron-Kinloss, West Grey, Arran-Elderslie, Brockton, Chatsworth, Grey Highlands, Hanover, Kincardine, Saugeen

Shores and Southgate. The Municipality sends one Council member to be our representative on the Board.

SMART is a specialized public transit service that provides accessible transportation services to the Municipality of Kincardine.

Community Investment Grant Committee

This Committee meets on an as needed basis to review Community Investment Grant Applications and make recommendations to Council. No future meetings have been scheduled and the majority of meetings happen in the 1st quarter each year.
