**BEING A BY-LAW TO ESTABLISH A PORTION OF LAND AS PART OF THE  
PUBLIC HIGHWAY SYSTEM FOR THE MUNICIPALITY OF KINCARDINE AND  
TO ASSUME AND DEDICATE THE SAID LANDS FOR ROAD PURPOSES**

---

**WHEREAS** Section 8(1) and 9 of the *Municipal Act, 2001*, S.O. 2001, c.25 as amended, provide that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues and has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**WHEREAS** Section 31 (2) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that land may only become highway by virtue of a by-law establishing the highway;

**AND WHEREAS** the property with the legal description of UNNAMED RD PL 445; PT LT 58 CON A KINCARDINE, PT 7 3R3036; (AKA TOWNSHIP RD) BTN RDAL BTN LT 60 & 61 CON A & RDAL BTN LT 50 & 51 CON A KINCARDINE, EXCEPT PTS 1, 2, 3 & 4 3R8736; S/T R370142, R370144 & R370145; KINCARDINE (PIN 33294-0418) Municipality of Kincardine, County of Bruce;

**AND WHEREAS** it is desirous to establish the aforementioned land as part of the Municipality's public highway system;

**AND WHEREAS** it is deemed expedient to assume and dedicate this land for road purposes;

**NOW THEREFORE** the Council of The Corporation of the Municipality of Kincardine **ENACTS** as follows:

1. The Corporation of the Municipality of Kincardine does here by establish the lands described as UNNAMED RD PL 445; PT LT 58 CON A KINCARDINE, PT 7 3R3036; (AKA TOWNSHIP RD) BTN RDAL BTN LT 60 & 61 CON A & RDAL BTN LT 50 & 51 CON A KINCARDINE, EXCEPT PTS 1, 2, 3 & 4 3R8736; S/T R370142, R370144 & R370145; KINCARDINE (PIN 33294-0418) as part of the Municipality's public highway system;
2. The said portion of the highway shall be known as "Victoria Street";
3. That the Mayor and Chief Administrative Officer be authorized and directed to execute, on behalf of the Council of The Corporation of the Municipality of Kincardine, documents to complete this transaction.
4. This By-law shall come into full force and effect upon its passage.

5. This by-law may be cited as the “Road Dedication (PIN 33294-0418 (LT) – Victoria Street) By-law”.

**READ a FIRST and SECOND TIME** this 3<sup>rd</sup> day of March, 2020.

**READ a THIRD TIME and FINALLY PASSED** this 3<sup>rd</sup> day of March, 2020.
