## Good afternoon,

We at Canadian Nuclear Laboratories (CNL) appreciate your interest in the <u>Douglas Point Decommissioning Project</u> and we'd like to share an update related to the project's licence amendment application.

This morning, Canada's nuclear regulator, the Canadian Nuclear Safety Commission (CNSC), released the dates for the hearing on the application we submitted to amend the current licence to a decommissioning licence. The hearing has been scheduled for June  $17^{th}$  and  $18^{th}$  of this year.

If granted, this licence would enable us to move towards further decommissioning work. However, we would still have to submit further documents and have these documents approved by the CSNC in order for the planned decommissioning work to begin. Essentially, obtaining a licence amendment is necessary, but not sufficient, for CNL to do additional decommissioning work.
