Quantity amounts for gravel, sidewalks and asphalt repairs have been adjusted in order to meet budget limits.

The Tender for winter sand included a provisional item allowing the Municipality to secure a cost to receive additional material during winter months during situations when current stockpiles become depleted. Depending on winter

conditions, operations may require more material than purchased and budgeted for to maintain our road network within compliance.

The operating tender for Calcium Chloride was extended from the 2019 year awarded to 552976 Ontario Limited, c/o Cliff Holland for 2020 as per By-Law No. 2020-005 passed on January 21st, 2020.
