NOW THEREFORE BE IT RESOLVED THAT Council enter into a 50% cost sharing agreement with the County of Bruce for the above noted project and that the \$30,000 come from the Streetlighting Fund Balance (Equipment Replacement Reserve Fund 49) and Lifecycle Reserve Fund 82.
