Dear Neighbour,

As you will know, Bruce Power's Operations, Environment Programs and Outage team members have been working hard to improve upon the site's already compliant noise levels, as confirmed independently by Ontario's Ministry of Environment, Conservation and Parks.

Following our 2017 announcement of a targeted project to install industrial silencers onto the deaerator bypass vents supporting each of the four operating units at the Bruce B Generating Station, we are very pleased to report that Bruce Power's noise mitigation project is currently progressing ahead of schedule – most recently with the completion of the associated work on Unit 6 earlier this week.

As part of our commitment to ensuring that local residents have timely information regarding this initiative and ongoing noise monitoring to confirm the project's success, we will be holding a community information session for local residents at the Bruce Power Visitors' Centre in June. Community Relations and technical staff from Bruce Power's Environment Programs group will be on hand to discuss the project and path forward to completion.
