We want to work with the Municipality of Kincardine to create bylaws to protect trees on private lands and private developments. Currently there are no protections for any private property trees or trees in private developments that happen. We are not against development, our Municipality is growing rapidly and lately every private development has cleared the land of all trees. We feel that these kind of developments are a disservice to everyone as well as the ecosystems that exist. There are cities and towns in Ontario with tree bylaws that are working. Developers are selected that are agreeable to protect where possible trees in a developments and if trees must be cut down when approved they must replant trees to replace those lost. Oakville has a well written defined tree protection policy and that is what we need. No need to reinvent the wheel here, just take their bylaws and make them work here. We need to leave trees for future generations to enjoy as well as some intact ecosystems intact. Also private landowners should not be able to cut down healthy trees of a certain size without a permit. We are a group of approximately 170 members who want to see changes in our tree protections.
